

Direxion Daily AVGO Bull 2X and Bear 1X Shares

Overview

The [Direxion Daily AVGO Bull 2X Shares](#) and [Direxion Daily AVGO Bear 1X Shares](#) seek daily investment results, before fees and expenses, of 200% and 100% of the inverse (or opposite), respectively, of the performance of the common shares of Broadcom Inc. (NASDAQ: AVGO).

Investing in the funds involves a high degree of risk. Unlike traditional ETFs, or even other leveraged and/or inverse ETFs, these leveraged and/or inverse single-stock ETFs track the price of a single stock rather than an index, eliminating the benefits of diversification. Leveraged and inverse ETFs pursue daily leveraged investment objectives, which means they are riskier than alternatives which do not use leverage. They seek daily goals and should not be expected to track the underlying stock's performance over periods longer than one day. They are not suitable for all investors and should be utilized only by investors who understand leverage risk and who actively manage their investments. The Funds will lose money if the underlying stock's performance is flat, and it is possible that the Bull Fund will lose money even if the underlying stock's performance increases, and the Bear Fund will lose money even if the underlying stock's performance decreases, over a period longer than a single day. **Investing in the Funds is not equivalent to investing directly in AVGO.**

Broadcom Inc. is an American multinational designer, developer, manufacturer, and global supplier of a wide range of semiconductor and infrastructure software products. Broadcom's product offerings serve the data center, networking, software, broadband, wireless, storage, and industrial markets. AVGO is registered under the Securities Exchange Act of 1934, as amended (the "Exchange Act"). Under the Operating Expense Limitation Agreement, Rafferty has contractually agreed to waive all or a portion of its management fee and/or reimburse the Funds for Other Expenses through September 1, 2026, to the extent that a Fund's Total Annual Fund Operating Expenses exceed 0.95% of the Fund's average daily net assets (excluding, as applicable, among other expenses, taxes, swap financing and related costs, acquired fund fees and expenses, dividends or interest on short positions, other interest expenses, brokerage commissions and extraordinary expenses). If these expenses were included, the expense ratio would be higher.*

Longer holding periods, higher volatility of AVGO and leverage increase the impact of compounding on an investor's returns. During periods of higher AVGO volatility, the volatility of AVGO may affect the fund's performance.

Important Information Regarding AVS

The Direxion Daily AVGO Bear 1X Shares (AVS) seeks daily inverse investment results and is very different from most other exchange-traded funds. Longer holding periods and higher volatility of AVGO increase the impact of compounding on an investor's returns. During periods of higher volatility, the volatility of AVGO may affect the fund's return as much as, or more than, the return of AVGO.

Leverage Risk – The Bull Fund obtains investment exposure in excess of its net assets by utilizing leverage and may lose more money in market conditions that are adverse to its investment objective than a fund that does not utilize leverage. A total loss may occur in a single day. Leverage will also have the effect of magnifying any differences in the Fund's correlation with AVGO and may increase the volatility of the Bull Fund.

Daily Correlation Risk - A number of factors may affect the Bull Fund's ability to achieve a high degree of correlation with AVGO and therefore achieve its daily leveraged investment objective. The Bull Fund's exposure to AVGO is impacted by AVGO's movement. Because of this, it is unlikely that the Bull Fund will be perfectly exposed to AVGO at the end of each day. The possibility of the Bull Fund being materially over- or under-exposed to AVGO increases on days when AVGO is volatile near the close of the trading day.

Daily Inverse Correlation Risk - A number of factors may affect the Bear Fund's ability to achieve a high degree of inverse correlation with AVGO and therefore achieve its daily inverse investment objective. The Bear Fund's exposure to AVGO is impacted by AVGO's movement. Because of this, it is unlikely that the Bear Fund will be perfectly exposed to AVGO at the end of each day. The possibility of the Bear Fund being materially over- or under-exposed to AVGO increases on days when AVGO is volatile near the close of the trading day.

Broadcom Inc. – AVGO faces risks associated with: the highly competitive nature of the semiconductor industry; failure to realize expected benefits from mergers, acquisitions and other joint ventures; economic and market uncertainty; reduced demand for its products; potential concentration of revenues in a few large clients; geopolitical and economic events and pandemics; among other risks. **Semiconductor Industry Risk** – Semiconductor companies may face intense competition, both domestically and internationally, may have limited product lines, markets, financial resources or personnel and may face risks related to the availability of materials. **Technology Sector Risk** — The market prices of technology-related securities tend to exhibit a greater degree of market risk and sharp price fluctuations than other types of securities.
