In connection with the dividend payments of \$0.0561 and \$0.06 per common share (ex dividend date March 3, 2025) payable on March 3, 2025 to shareholders of record on February 28, 2025 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 12% of such dividend will be a return of capital, 88% ordinary income (including short-term capital gains) and 0% long-term capital gains.
