In connection with the dividend payments of \$0.0561 and \$0.06 per common share (ex dividend date February 3, 2025) payable on February 3, 2025 to shareholders of record on January 31, 2025 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 25% of such dividend will be a return of capital, 75% ordinary income (including short-term capital gains) and 0% long-term capital gains.
